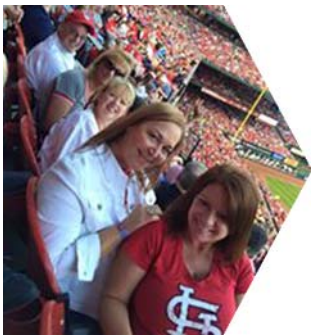


Getting Involved with ALA Gateway
